The 26th International Euro-Asia Research Conference Hybrid On line / Poitiers (France), December the 7th to the 9th, 2022 Call for Papers

Corporate Social Responsibility in a time of crisis, European and Asian perspectives.

Following a number of conferences held in France, Japan, Korea, Germany, Ireland, Norway, Italy, China, Spain, Indonesia and India since 1994, the Twenty Sixth International Euro-Asia Research Conference will take place in a hybrid format, at distance on line and in Poitiers (France) from December the 7th to the 9th, 2022. Research contributions addressing any aspects of *Corporate Social Responsibility in a time of crisis, European and Asian perspectives* are welcome. Besides this theme, other papers in the fields of economics and management with a particular reference to Asia may also be submitted.

The Research Seminar is a joint undertaking between University of Poitiers (France), Technological University Dublin (Ireland), The University of Limerick (Ireland), the University of Pau (UPPA, France), Yokohama National University (Japan), the Ruhr Universität Bochum (Germany), the School of Asian Studies and Business Management, Ca' Foscari University, Venice (Italy), Institut Mines-Telecom Business School (France), The School of East Asian Studies, University of Sheffield (U.K).

The Research Seminar is intended to bring together researchers engaged in Management, Economics, Political Science and related fields from Europe, Asia and other parts of the World. Doctoral students are also strongly encouraged to submit papers for consideration.

Venue, Registration Fees, Accommodation and travel

The 2022 Research Seminar is jointly organized by University of Pau, Technological University Dublin and University of Poitiers. It will take place in Poitiers (France) on a hybrid format, in Poitiers for those who may come, and on line for the others. The hybrid format has been chosen because of the still uneven sanitary situation. The Research Seminar fee for those who come to Poitiers is $250 \in$ and includes two dinners, two lunches, coffee breaks and a copy of the conference proceedings; it is $50 \in$ for those who participate on line.

Available funding does not allow the organizing committee to provide financial support to participants in relation to accommodation and travel expenses. However, special assistance for accommodation booking in or near Poitiers will be provided, close to the Seminar venue.

Submission Rules

Papers in English should be original and not submitted for publication elsewhere. They may either be related to a particular country or be of a comparative nature. Papers accepted for presentation at the Seminar will be published as Conference Proceedings. Furthermore, a number of selected papers will be published in scholarly journals or/and books. Proposals for panel sessions will also be considered.

A two-page abstract in English (including bibliography) should be submitted by 2022, July the 4th, to the following e-mail address: euro-asie@univ-pau.fr. A title page with a complete list of authors, their academic position, addresses, phone and fax numbers as well as E-mail should be included separately. The decision of the Scientific Committee will be communicated to the authors by 2022, July the 12th. The final paper, including an abstract of around 300 words, should be forwarded by 2022, November the 6th. Length should not exceed 6,000 words or 15 single-spaced pages (including tables, figures, and references).
